Additional Terms and Agreements

The undersigned as RENTER (including any and all RENTERS signing the Agreement), hires from **Marine Plus, Inc.** as OWNER, Boat Bayliner on the following terms and conditions.

Please initial each item as it is read and understood:

(Initial) The RENTER must return the boat to the OWNER at or before _____ (Time of Return) on _____ (Date)

(Initial) Navigation of power boats is confined to Lake Champlain and it's Vermont tributaries or local Vermont Lakes or ponds.

(Initial) The RENTER shall keep his copy of this agreement in his possession during the rental period and must present it to the OWNER at time of return for preparation of the final invoice.

(Initial) RENTER acknowledges that the boat is the rightful property of the OWNER, and further acknowledges that he received said boat in good and safe mechanical and seaworthy condition. RENTER agrees to return said boat together with all accessories and accouterments to the OWNER in the same condition as RENTER received it. Said boat is equipped with life jackets or buoyant cushions (number specified above), paddle, anchor and line, fire extinguisher, flares ,horn and a full tank(s) of fuel.

(Initial) RENTER agrees to pay to OWNER the cost of replacing lost equipment and the cost of repairing damages to, and caused by, the boat including parts, labor expenses of transporting said vessel or other property to and from point of repair, **all towing charges**, including, **but not limited to all towing charges as a result of grounding or beaching of the boat**, regular rental fee covering time said vessel is out of service as a result of damage, and any collection cost and / attorney fees necessary to secure reimbursement. It is understood that the security deposit ("Deposit") will be used for payment of all or part of the above cost up to its full amount. Cost in excess of the Deposit shall be paid by the RENTER to the OWNER on demand.

[](Initial) RENTER agrees to pay the OWNER on demand all time, fuel, oil, service, minimum, and other charges applicable to the rental of the boat at the rates or in the amounts specified herein.

[](Initial) RENTER who signs to accept the terms of this Rental Agreement certifies that he or she is 18 years of age or over and declares that he/she is experienced and qualified properly to handle the boat rented herein.

[](Initial) RENTER agrees that the use of the boat by a number of persons greater than the number of life jackets or buoyant cushions provided (all children are required to wear a life jacket at all times) is illegal.

[](Initial) RENTER acknowledges that it is unlawful for any person to fish from a boat without a valid Vermont fishing license fishing license.

[](Initial) RENTER agrees to operate the boat in a safe and legal manner as prescribed by all laws and regulations applicable to the area in which the boat is operated. Alcoholic beverages are prohibited on all vessels.

[](Initial) RENTER agrees that during the term of this agreement the Renter shall be in full control of the rented boat and it is expressly understood that the Renter is not the agent, servant or employee of the Owner, in any way whatsoever, and that the Owner is not responsible for injuries sustained by Renter, his guests and employees and is held harmless in everyway.

[](Initial) RENTER agrees that the Owner herein assumes no responsibility for weather conditions which may arise or occur during the term of this agreement, and all rates and agreements will continue in full force and effect until the return of the boat to Owner.

[](Initial) RENTER agrees:

- a) To notify the Owner immediately of any accident involving the boat.
- b) On demand, to reimburse the Owner for the cost of all damages to the boat and equipment resulting from accident, collision, theft or loss.
- c) To release the owner and/or boat from any claim for loss and/or injury of any nature whatsoever
- d) To indemnify and save the Owner and/or boat harmless from any claim for liability for loss and/or injury to any other boat, property or persons, including all occupants of the boat hereby rented, by reason of accident involving the said boat during this rental or as a result of the operation of the boat in violation of any law or ordinance.

[](Initial) RENTER agrees This contract constitutes the entire agreement by and between the parties hereto and no oral or implied agreement or understanding shall cancel or vary the terms of this contract unless reduced to writing and signed by the parties hereto.

[](Initial) RENTER agrees that both parties acknowledge that they have read the foregoing provisions all of which they are in complete understanding and agreement.

[](Initial) RENTER Agrees that the rental amount due is for the full rental period regardless of any early returns or cancellations for any reason.

RENTER AGREES THAT HE OR SHE HAS READ AND UNDERSTANDS ALL OF THE ABOVE TERMS AND CONDITIONS AND AGREES TO INDEMNIFY
