## Consignment Terms of Agreement

CONSIGNOR being OWNER of Property.

I am the consignor/owner of said property listed on reverse side of this agreement. Per terms and conditions stated herein. I am placing said property on consignment with *Marine Plus, Inc.*

All Consignors must present proof of ownership/and or right to sell the property presented Marine Plus, Inc. for sale. Title work must be in order prior to the selling of boat.

### LIABILITY/INSURANCE

Consignors must have insurance on their boats until sale is complete.

I fully understand and agree that Marine Plus, Inc. is not and will not be held liable for any items left in boat; including covers, depthfish finders, stereo's, towables, ski's, etc.

We do ask that any and all items that are to be represented with the boat be on the boat at time of sign-in.

Marine Plus, Inc. will not be held liable for any damages or loss to said boat referenced on reverse side of this contract, Including, but not limited to: fire, theft, natural disaster, vandalism, collision, acts of God, and/or any type of property loss.

### CONDITION OF PROPERTY /ACCESSORIES INCLUDED

Consignor guarantees that said boat is in good running condition and will pass a lake demonstration. Should mechanical or cosmetic repairs become an issue in regards to selling the boat, owners will be consulted prior to, and responsible for, any cleaning, or repairs needed, including but not limited to summer commissioning or winterization, batteries, impellers, parts, and/or labor. Further any items and/or accessories listed on the consignment sheet shall be included in the final agreed sales price.

### FUNDING

IF owner has clear title, funding will be paid when Marine Plus, Inc. receives all proper title work in office. NOTE: there may be a slight delay in funding if a lending institution requires Marine Plus, Inc. to produce titles prior to funding monies Consignor, further understands and agrees that funding of sold property will not be immediate if owner has a lien against property, funding can take up to 20 working days of from date of sale depending on the process involved such as paying off lien holders, transferring ownership, timely closing's and title release with lien holder and/or owner. If a lost or duplicate title is applied for, the process will take longer. In these instances, Marine Plus, Inc. are at the mercy of banks/mail/gov. agencies and cannot guarantee specific date of payment,

### FEES/CHARGES/COMMISSION

Marine Plus, Inc. charges a commission of 10% of the final agreed sale price. Owner agrees to contract with Marine Plus, Inc. for a minimum of 90 days. Marine Pus will still receive 10% commission if sale is negotiated by owner if sold from Marine Plus property within the 90 days consignment period. Sea trials may be charged as an additional expense.

Individual sales agreements can be negotiated with different terms.
